According to the Article 61 paragraph (1) item a) of the Law on Higher Education (Official Gazette of the Canton Sarajevo, no. 36/22) and Article 95 of the Statute, No. IUS-SENAT-11-1720/2023, upon the Article 7 of the Book of Rules on Adoption, Changes, and Evaluation of Study Programs at IUS, No. IUS-SENAT-11-814/23, the Senate of the International University of Sarajevo, on its 168th meeting held on September 29th, 2023, adopted the following

DECISION
on adoption of the integral (harmonized) versions
of curricula and syllabuses

I

With this decision, the harmonized (integral) versions of all adopted curricula and syllabuses are hereby adopted i.e. whose decisions on changes were made during 2022-2023 AY and which are applied as such starting from the fall semester of 2023-2024 AY.

II

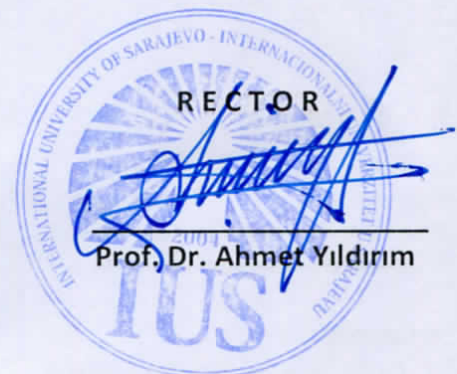
Analogously to the previous item, all the harmonized (integral) versions of curricula and syllabus in the previous years should be considered as adopted (with the reference to that AY), upon the condition that the decision on changes was made in a prescribed procedure.

III

The integral versions of the harmonized curricula and syllabuses from this decision are equally considered as those attached herein, or those that are electronically stored in accordance with the *Instruction on the establishment and maintenance of an electronic register of curricula and syllabuses*, no. IUS-REC-01-174/2022 dated January 24th 2022.
