*Pursuant to Article 76 of the Law on Higher Education ("Official Gazette of Canton Sarajevo", issue No. 43/08, 18/10, and 15/13) and Article 4 of the Statute of the International University of Sarajevo, Senate of the International University of Sarajevo, on its session held on October 31, 2013, adopted the following*

**DECISION**

**I**

It is hereby established the right of IUS graduates to receive diploma and diploma supplement at prearranged time of the month upon their written requests and after all financial obligations towards IUS are fulfilled.

**II**

Relevant IUS offices are instructed to issue diploma and diploma supplement to the IUS graduate upon the verification of the fact that conditions for issuing the documents are met by the graduate and not exceeding 30 days from the day IUS received the request.

**III**

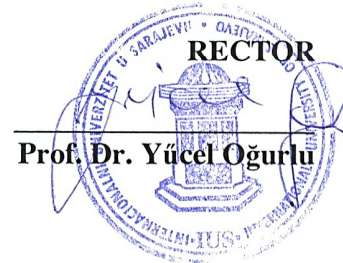
In case a failure to fulfill any of the obligations prescribed by a curriculum, or failure to fulfill all financial obligations is found on the part of the graduate, relevant office will provide written document to the graduate in which it would reject his/her request until all requirements are completed.

**IV**

This decision enters into force upon its adoption.

#### II

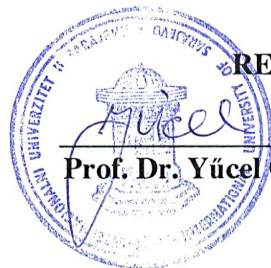
