In accordance with the Article 103 (2) a) of the Law on Higher Education ("Official Gazette of Canton Sarajevo", 33/17), Senate of the International University of Sarajevo, on its meeting held on December 8, 2017, unanimously adopted the following

DECISION

I

A comparative international grade system of the International University of Sarajevo is harmonized in accordance with the table given in the addendum to this Decision, which constitutes its integral part.

II

Harmonized international grade system referred in Article I of this decision will be used to facilitate comparison of academic success of International University of Sarajevo students with the students who are graduating study programs at universities which are using grade point average as indicator for student academic success.

III

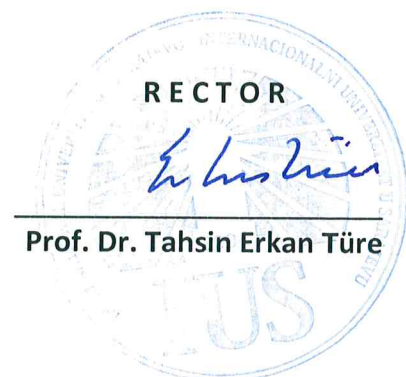
Achieved score from 45 to 54 points on a course is considered sufficient for satisfying prerequisite requirement, if that course is prerequisite for attending another course.

IV

On the day this decision comes to force, Senate decisions number IUS-SENAT-11-458/2011 from May 12, 2011 and number IUS- SENAT-11-541/2011-I from May 25, 2011 will no longer be in use.

V

The decision shall enter into force on February 19, 2018.

Pursuant to Article 56 paragraph (1) of the Law on Higher Education (Official Gazette of Sarajevo Canton No. 33/17), acting upon Conclusion of Council of FENS, No.: US-FENS-06-90/20, dated January 10th, 2020, Senate of the International University of Sarajevo, at its 119th session held on January 13, 2020, adopts the following

DECISION

I

This Decision amends the Senate's decision, No. IUS-SENAT-11-3336-1 / 2017 of December 8th, 2017, as follows:

II

Article III is amended and it now reads:

"Achieved score from 45 to 54 points on a course is considered sufficient for satisfying prerequisite requirement, if that course is prerequisite for attending another course, except for professional-artistic courses which are determined by Faculty Council as such."

II

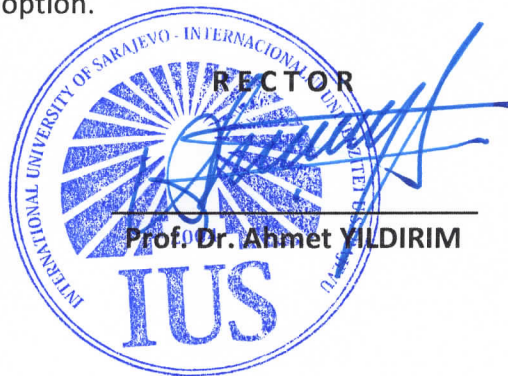
Other provisions of the above stated decision remain unchanged.
